

Doggie Daycare/Boarding Agreement for:

- 1. I am the legal owner or authorized agent of the above listed dog(s) and authorize Melinda Hammelman and My Big Bark Yard to board and care for my dog(s) while I am away. I will not hold Melinda Hammelman or My Big Bark Yard responsible for any injuries obtained while in their care.
- 2. I realize that my dog(s) may be co-mingling with other dogs. I understand that there are risks and benefits to group socialization of dogs. I agree that the benefits outweigh the risks. I desire a socialized environment for my dog(s) while attending services provided by My Big Bark Yard and while in their care. I understand that while the socialization and play is closely and carefully monitored to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs.

I will be held responsible for any veterinary bills incurred for treatment of my dog(s). I will also be responsible for any medical treatment and charges if my dog ingests or gets injured by any material in the daycare/boarding environment. (toys, bedding, footing, sticks, etc). Under no circumstances will Melinda Hammelman or My Big Bark Yard be liable for consequential damages.

3. I agree to pay the daycare charges at the rate of \$40 per day and/or boarding charges at the rate of \$50 per day. Additional dogs from the same household are \$30 per day for daycare and \$40 per day for boarding. Puppies (under 1 year) are \$50 per day for daycare or \$60 per day for boarding. Balances will be paid in full at or prior to the beginning of the booking with cash ONLY. My Big Bark Yard reserves the right to adjust daycare and/or boarding rates at any time.

- 4. Cancellation policy: My Big Bark Yard reserves the right to charge a cancellation fee of 100% for services canceled within 1 week prior to the scheduled service. Cancellations made within 3 weeks prior to the scheduled service will be charged a 50% fee. Payment of the cancellation fee is due on the date of the cancellation. If payment is not made, My Big Bark Yard reserves the right to terminate this agreement and will no longer accept the Client for future bookings.
- 5. My Big Bark Yard reserves the right to terminate this contract at any time if it determines that the Client's dog(s) poses a danger to the health or safety of itself, other pets, other people or anyone at My Big Bark Yard. Aggressive behavior will not be tolerated. If concerns prohibit My Big Bark Yard from caring for the dog(s), My Big Bark Yard will attempt to contact the Client to arrange alternative care. If the Client cannot be contacted, the Client authorizes My Big Bark Yard to place the dog in a licensed kennel with all charges and fees arising to be the responsibility of the Client. No refund will be given if cancellation occurs due to aggressive behavior.
- 6. My Big Bark Yard reserves the right to refuse service to any client, at any time, for any reason.
- 7. Client authorizes the use of dog(s) pictures on My Big Bark Yard's website, social media and/or marketing materials for promotional purposes.
- 8. Client authorizes this contract to be valid approval for services so as to permit My Big Bark Yard to accept all future in person, telephone, online, mail or email reservations and provide services without additional signed contracts or written authorizations.
- 9. The terms of this document apply to all dogs owned by the client, including any and all new dogs that the client obtains on or after the date this document was signed.
- 10. Vaccines are REQUIRED for my dog(s) to be admitted into My Big Bark Yard. I understand that while vaccines assist in disease prevention, My Big Bark Yard cannot guarantee my dog's health during his/her stay. I agree to treat my dog(s) for fleas before

their stay and understand that although treated there is still a chance that fleas will come home with my dog(s).
